Apples, Sugar, Sunflower Oil, Ascorbic Acid, Citric Acid

Product Description:

This product is prepared in accordance with good manufacturing practices by infusing IQF diced apples in a cane sugar solution. Subsequently infused apples are dried to a specified moisture range. Sunflower oil is topically applied. The finished product is analyzed for quality, inspected and passed through a metal detector.
